EPA Released its Technical Support Materials for the Final Aquatic Life Ambient Water Quality Criterion for Selenium – Freshwater 2016

On April 8, 2024, the EPA released the [Technical Support Materials for the EPA's Final Aquatic Life Ambient Water Quality Criterion for Selenium – Freshwater 2016](#). These documents support state and Tribal adoption and implementation of the EPA's [Final Aquatic Life Ambient Water Quality Criterion for Selenium – Freshwater 2016](#) (published on July 13, 2016). Consistent with the latest scientific information, the national recommended criterion is intended to protect the aquatic life designated use in freshwater from the negative effects of selenium.

The final technical support materials documents provide implementation support related to (1) criterion adoption, (2) monitoring fish tissue, (3) assessing and listing waters under CWA section 303(d), and (4) NPDES permitting. TRIBAL CONSULTATION OPPORTUNITIES

EPA's Approach to Improving Performance Reporting in Agency Grant Programs

Deadline: April 12, 2024

EPA's Office of the Chief Financial Officer (OCFO) invites federally recognized Indian Tribes to provide input on the agency's ideas for improving performance reporting in its grant programs.

The agency has the opportunity to develop a performance reporting framework that articulates common post-award performance elements across grant programs, in order to clarify expectations, reduce reporting burden for grantees, and improve the quality of performance information that is collected across the EPA. The agency is developing guidance to define and explain different components of performance reporting that may be used by grant programs that do not have a performance reporting framework in place.

The deadline to request for a one-on-one tribal consultation meeting is March 29, 2024. The deadline to submit a comment is April 12, 2024. Consultation materials are available on EPA's Tribal Consultation Opportunities Tracking System (TCOTS) website located at: <https://tcots.epa.gov>.

EPA's Sixth Proposed Unregulated Contaminant Monitoring Rule (UCMR 6) for Public Water Systems

Deadline: June 20, 2024

EPA is initiating consultation and coordination with federally recognized Indian Tribes on the development of the sixth Unregulated Contaminant Monitoring Rule (UCMR) for public drinking water systems. Under the UCMR, EPA collects data for contaminants suspected to be found in drinking water, but that do not have health-based standards set under the Safe Drinking Water Act.

EPA will be holding upcoming webinars to describe potential approaches for developing UCMR 6, which includes prospective drinking water analytical methods and contaminants, possible sampling design, and other monitoring considerations.

First Nations Development Institute: Advancing Tribal Nature-Based Solutions Grants

Deadline: May 22, 2024

Tribes and Native communities are on the front lines of climate change, experiencing extreme weather, rising sea levels, extended drought, warming temperatures, and melting permafrost. Many tribes and Native communities are located in remote and coastal locations, which increases their vulnerabilities to flooding and wildfire. Furthermore, subsistence and cultural practices rely on healthy ecosystems that are stewarded by Native peoples.

To support climate action that addresses adaptation and disaster preparation, First Nations established the second project under its newly created Climate Initiative, Advancing Tribal Nature-Based Solutions. This project is designed to provide tribes and Native nonprofits with resources to support climate action that addresses adaptation and disaster preparation (e.g., wildfires, flooding, drought) through the application of nature-based solutions based on Native knowledge. First Nations expects to award six (6) grants up to \$200,000 each to eligible tribes and organizations.
